



# ArtWORKz 2026

ArtWORKz is an art show and competition open to all youth under the age of 19. There is no fee to enter. Entries will be judged by a panel of established artists and will be displayed for six weeks in the Temporary Exhibit Gallery at Tamástslíkt Cultural Institute.

## Artist Categories

- Age 10 & Under
- Age 11-14
- Age 15-18

## Eligibility

- Open to all young artists under the age of 19.
- Open to tribal and non-tribal youth.
- Submissions may be an individual's work or it may be a collaborative effort in which case all artists must be identified. Any artists in collaboration must be under age 19.
- Only one entry per artist is allowed.

## Prizes

- (1) Grand Champion for all categories will receive a \$500 gift certificate for art supplies donated in their name to their school/program of choice.
- (1) Grand Prize winner per category.
- (1) Award of Excellence per category.
- (1) Award of Merit per category.
- Honorable Mentions awarded at judge's discretion.
- (1) Artist's Choice for all categories. Winner will be determined by vote of competitors at the Artist's Reception.

## Judging

- Judging will be based on artistry, creative vision, technical merit and presentation.
- The Tamástslíkt Director reserves the right to make all final decisions.
- Judging panel reserves the right to not award a category if it's determined that no submission is deserving.

## Submission Guidelines

- All entries must be gallery ready.
- **A W9 form must be submitted with the entry form if the artist plans on selling their artwork. If the W9 is not completed and submitted with the entry form, Tamástslíkt Cultural Institute will not process the sale of the artist's work.**
- Submission mediums may include sculpture, painting, drawing, printmaking, glass, mixed media, photography, computer-generated art, fiber art, and any discipline of artwork that includes traditional tribal handwork.
- All paintings must be dry, appropriately presented, mounted or framed, and ready to hang with screw eyes, wires attached or sawtooth hangers.

- Submissions will not be accepted without a frame, matting or rigid construction.
- All forms of media are acceptable unless installation requirements cannot be met by TCI.
- All artist attributions must be correct and verifiable.
- All entries must arrive with (1) completed Incoming Loan Form and (1) Artist Entry form.
- If entry form is illegible or incomplete, the art will not be considered for the competition.
- Teachers are welcome to submit as a class or school by using (1) completed Incoming Loan Form filled out by the teacher, and completed individual entry forms from all artists.

### **Deadline**

- All work must be submitted by March 30, 2026

### **Exhibit Dates**

- ArtWORKz opens to the public on April 3, 2026 and closes May 16, 2026.

### **Artist's Reception**

- Artist's Reception date is April 18, 2026 at 1:00 p.m. at Tamástslíkt Cultural Institute.
- All artists, parents and the public are invited.
- All prizes will be awarded, artists and supporters will be recognized.
- Refreshments will be served.
